The REIT Manager had, on 9 October 2020, launched a non-renounceable preferential offering of 324,639,666 new Units ("New Units") on the basis of 290 New Units for every 1,000 existing Units (fractions of a New Unit to be disregarded) held as at 5.00 p.m. on Tuesday, 6 October 2020 (the "Preferential Offering"). Under the Preferential Offering, 174,683,751 New Units were issued to FPRTH.

The percentage of unitholdings "immediately after the transaction" is based on 1,688,767,793 Units in issue as at 27 October 2020.
