On 27 November 2020, the REIT Manager received 8,231,488 new units in FCT ("New Units") as payment of the acquisition fee of S\$19,343,997.43 in connection with the acquisition of approximately 63.11% of the total issued share capital of AsiaRetail Fund Limited and 231,729 New Units as payment of the divestment fee of S\$540,000.00 in connection with the divestment of a leasehold interest in the whole of the land lots 4710W, 4711V, 10529L and 10530N all of Mukim 27 together with the building erected thereon, situated at 799 New Upper Changi Road, Singapore 467351, currently known as Bedok Point at an issue price of S\$2.3500 per New Unit and S\$2.3303 per New Unit respectively. MMC is therefore deemed interested in an aggregate of 697,137,053 Units.
