# PAYMENT OF MANAGEMENT FEE BY WAY OF UNITS IN FRASERS CENTREPOINT TRUST

Frasers Centrepoint Asset Management Ltd. (the "**Company**"), as the manager of Frasers Centrepoint Trust ("**FCT**"), wishes to announce that the Company has on 27 October 2023 received 3,580,068 units in FCT ("**Units**") issued at a price of S\$2.1903 per Unit (the "**Issue Price**") as payment of the following: -

- 20% of the performance fee component of its management fee for the period from 1 October 2022 to 31 March 2023;
- 35% of the performance fee component of its management fee for the period from 1 April 2023 to 30 June 2023; and

The payment of the Company's management fee in the form of Units is provided for in the trust deed constituting FCT dated 5 June 2006 (as amended, restated and supplemented). The Issue Price is the volume weighted average price of the Units traded on Singapore Exchange Securities Trading Limited for the last ten business days of the Fourth Quarter 2023.

With the above issue of Units, the Company holds an aggregate of 85,290,961 Units and the total number of Units in issue is 1,712,039,299.
