

## **FRASERS CENTREPOINT TRUST**

### **PAYMENT OF MANAGEMENT FEE BY WAY OF UNITS IN FRASERS CENTREPOINT TRUST**

Fraser's Centrepoint Asset Management Ltd. (the "**Company**"), as the Manager of Fraser's Centrepoint Trust ("**FCT**"), wishes to announce that the Company has on 29 July 2025 received 1,506,018 units in FCT ("**Units**") issued at a price of S\$2.2367 per Unit (the "**Issue Price**") for payment of the following base fee components of its management fee payable to the Company for the period from 1 April 2025 to 30 June 2025 (both dates inclusive) (the "**Relevant Period**"):

- (i) 51% of the base fee component of its management fee for the Relevant Period<sup>1</sup>; and
- (ii) 100% of the base fee component of its management fee in relation to FCT's 50.0% effective interest in NEX received from Fraser's Property Coral Pte. Ltd. (in its capacity as trustee-manager for NEX Partners Trust) for the Relevant Period.

The payment of the Company's management fee in the form of Units is provided for in the trust deed constituting FCT dated 5 June 2006 (as amended, restated and supplemented). The Issue Price is the volume weighted average price of the Units traded on Singapore Exchange Securities Trading Limited for the last ten business days of the Relevant Period.

With the above issue of Units, the Company holds an aggregate of 111,457,280 Units and the total number of Units in issue is 2,029,316,420.

- (1) The management fee indicated in paragraph (i) for the Relevant Period excludes the base fee component of its management fee in relation to FCT's 50.0% effective interest in NEX received from Fraser's Property Coral Pte. Ltd. (in its capacity as trustee-manager for NEX Partners Trust) for the Relevant Period.
