Frasers Property Limited ("FPL") holds a 100% direct interest in each of FCAM and Frasers Property Retail Trust Holdings Pte. Ltd. ("FPRTH"). FCAM and FPRTH hold units in FCT ("Units"). FPL therefore has a deemed interest in the Units in which each of FCAM and FPRTH has an interest, by virtue of Section 4 of the Securities and Futures Act 2001 of Singapore.

Charoen Sirivadhanabhakdi and the estate of the late Khunying Wanna Sirivadhanabhakdi, each owns 50.0% of the issued and paid-up share capital of TCCA Assets Limited ("TCCA");

- TCCA holds a majority interest in FPL;
- FPL holds a 100% direct interest in each of FCAM and FPRTH; and
- each of FCAM and FPRTH directly hold units in FCT.

The estate of the late Khunying Wanna Sirivadhanabhakdi therefore has a deemed interest in the units in FCT in which FPL has an interest, by virtue of Section 4 of the SFA.

FCT is a real estate investment trust. The manager of FCT is FCAM (the "REIT Manager").

The REIT Manager had, on 27 October 2025, received 5,562,764 New Units issued at a price of S\$ 2.3372 as payment of the following:

- (i) 20% of the performance fee component of its management fee for the period from 1 October 2024 to 31 December 2024;
- (ii) 20% of the performance fee component of its management fee for the period from 1 January 2025 to 31 March 2025;
- (iii) 51% of the performance fee component of its management fee for the period from 1 April 2025 to 30 June 2025;
- (iv) 66% of the base fee component and performance fee component of its management fee for the period from 1 July 2025 to 30 September 2025;
- (v) 100% of the performance fee component of its management fee in relation to FCT's 50.0% effective interest in NEX received from Frasers Property Coral Pte. Ltd. (in its capacity as trustee-manager for NEX Partners Trust) for the period from 1 October 2024 to 30 June 2025; and
- (vi) 100% of the base fee component and performance fee component of its management fee in relation to FCT's 50.0% effective interest in NEX received from Frasers Property Coral Pte. Ltd. (in its capacity as trustee-manager for NEX Partners Trust) for the period from 1 July 2025 to 30 September 2025.

The percentages of unitholding before and after the issuance of the New Units are calculated based on 2,029,390,226 units of FCT in issue before the issuance of the 5,562,764 New Units and 2,034,952,990 units of FCT in issue after such issuance respectively.
